The QDC, a quasi-State agency, is a special purpose subsidiary of the Rhode Island Commerce Corporation (RICC) responsible for the development and management of the 3,212-acre Quonset Business Park, located in North Kingstown, RI. Through an agreement with the RIANG, QDC will temporarily assume certain Owner's rights and responsibilities in order to oversee, manage, and execute this facility/infrastructure replacement project through the National Guard Bureau's (NGB) Military Construction Cooperative Agreement (MCCA) process.

This is a Request for Qualifications (RFQ), not a Request for Proposal (RFP) for a scope or fee. Currently, the QDC is authorized by the NGB and RIANG to procure the following design services:

- Site Investigation (Type A1) (15% design)
- Site Investigation (Type A2) (35% design) (funding contingent upon NGB approval of Type A1 design)
- Design of ANG Improvements (Type B) (100% design) (funding contingent upon NGB approval of Type A1 and A2 design)
- The above services will be 100% funded by Military Construction (MILCON) funds. The Consultant/Team shall also be capable of providing Type C Services.

QDC requests a Statement of Qualifications (SOQ) from interested firms. This is a Request for Qualifications (RFQ). Consultant selection will be completed utilizing the following:

- The SOQ will be evaluated and ranked by a panel of QDC personnel based on the criteria outlined in *Section VII. Evaluation and Selection*.
- The QDC may, at its sole discretion, elect to require presentation(s) by one or more Firms/Teams.
- Upon final rankings, the QDC will identify the most qualified competitor, and that Firm/Team shall be afforded the opportunity to negotiate a "fair and reasonable, not-to-exceed" scope and fee with the QDC for each of the design stages noted above. If a "fair and reasonable, not-to-exceed" scope and fee cannot be agreed upon by both parties, the QDC reserves the right to end negotiations and negotiate with the second most qualified competitor. This process, if necessary, shall be repeated down the line until a "fair and reasonable, not-to-exceed" scope and fee is agreed upon by the QDC and a selected Firm/Team.
