The plan scale reads 1'' = 20' however upon doing the take off it appears to be scaling at 1'' = 66'.

This can vary in material quantities drastically and could lead to inaccurate bidding.

The typical plan view scale is 1'' = 20' as noted in the lower title block. Drawings printed at full scale are  $24'' \times 36''$ . This was confirmed in Adobe, Bluebeam, and on a full size set of drawings. If plotting to a smaller paper size such as  $11'' \times 17''$ , take note that the proper scaling (50%) is applied in the print dialogue. True half-size plans will scale at 1'' = 40'.
