This is a Request for Proposal (Bid #6099) for the evaluation of Law Enforcement Assisted Diversion: Engagement & Retention (LEADER) in Treatment, a pre-prosecution diversion program to help those with substance use disorder. The goal of this RFP is to secure a qualified organization to review program data and disseminate a number of different evaluation reports. The project is funded, in part, by the Bureau of Justice's Comprehensive Opioid, Stimulant, and Substance Abuse Program (COSSAP) funds. As such, associated Federal rules and regulations apply, including, but not limited to, Davis Bacon wage requirements. The project will be managed by the Woonsocket Police Department. Specifications are available on the City's Purchasing webpage and the State of Rhode Island's purchasing website.

1. Introduction

The Woonsocket Police Department has secured funding to evaluate a pre-prosecution diversion program that serves individuals at high risk for overdose or suffering from substance use disorder by implementing a law enforcement diversion program that incorporates a variety of multidisciplinary overdose prevention, response, diversion, and referral models.

The scope includes collecting data, reviewing the data, and creating a number of reports. The evaluation team will assist the Project Coordinator in establishing data collection processes, analyzing the data, and providing regular feedback to the team throughout the project. They will contribute to the development of dissemination resources, such as manuscripts, policy briefs, and meeting reports. The reports also include a series of brief communications throughout the grant life as well as process, implementation, and impact evaluation reports.

The goal of the evaluation is to provide data and reports that monitor and evaluate the activities and outcomes of the LEADER program. Also, to provide important and interesting insights and findings throughout the grant life.

2. Questions

5. Scope of Work

The Woonsocket Police Department has secured funding for the evaluation of a Law Enforcement Assisted Diversion: Engagement & Retention (LEADER) in Treatment at 242 Clinton St, Woonsocket, RI.

LEADER in Treatment is a pre-prosecution diversion program that serves individuals at high risk for overdose or suffering from substance use disorder by implementing a law enforcement diversion program that incorporates a variety of multidisciplinary overdose prevention, response, diversion, and referral models.

The evaluation team will work with the LEADER program staff to identify the key issues they want evaluated and then conduct the data collection and analysis of these components. The evaluation team will assist the Project Coordinator in establishing data collection processes, analyze the data, and provide regular feedback to the team throughout the project. Feedback will include a year one process evaluation report, year two implementation evaluation report, year three impact evaluation report, quarterly financial reports, and quarterly performance measurement reports. They will contribute to the development of dissemination resources, such as manuscripts, policy briefs, and meeting reports. They will also participate in COSSAP grantee meetings in years 2 and 3.

Through this RFP, the Woonsocket Police Department is seeking a Successful Proposer to assist with the evaluation of the LEADER program. The Police Department envisions that the Successful Proposer take the role of Principal Investigator and will recruit, employ, and supervise four staff who will be assigned to the LEADER program which will be launched in the Fall of 2022.

- A. One Principal Investigator who will collaborate with local evaluation staff and dedicate 4 hours/week to the project. They will also provide editing services and conduct 2 site visits per year to Woonsocket.
- B. One 1% FTE Site Project Director who will oversee all required grant reporting activities, establishing the process evaluation protocols, dissemination of results, and ensuring adherence to all grant timelines and objectives. They will be responsible for ensuring compliance with all evaluation requirements and will oversee all evaluation activities. The Director will oversee all dissemination efforts, including manuscript preparation, policy briefings, and other dissemination activities.

- C. One 1.5% FTE Evaluator who will contribute to oversight of the evaluation activities and will lead the process and program evaluations and analyses. They will have an active role in all dissemination efforts, including manuscript preparation, policy briefings, and other dissemination activities. The evaluator will oversee all activities related to the process evaluation and mixed methods data management and analysis.
- D. One 2% FTE Assistant Evaluator who will assist both the on-site Project Director and Evaluator in appropriate grant reporting and evaluation activities, conducting process evaluation and data management and analyses, and dissemination of findings. They will be the primary liaison between the evaluation team and the community-based teams, including the police department and associated justice partners, as well as the community treatment partner.
- E. One 15% FTE Research Assistant who will assist the team throughout the grant with all evaluation and dissemination activities. They will contribute to the monitoring of the program and data.

The Successful Proposer must include the following in their proposed budget:

- The cost of staff time and benefits.
- The cost of equipment and supplies needed. This should include the cost of a laptop for the research assistant.
- The cost of all travel expenses for site visits.
- The cost of mileage to attend meetings.
- The cost of dissemination.

Successful Proposers must submit a line-item budget that provides a complete breakdown of all costs, including how the costs were calculated. Budgets should be shown on an annual basis. The Year 1 budget should include October 1, 2022 to September 30, 2023. The Year 2 budget should be from October 1, 2023 to September 30, 2024. An optional third-year budget that covers the time period from October 1, 2024 to September 30, 2025, should also be included.

6. Schedule

The proposal should include a commitment to begin the project no later than December 1, 2022.

7. Preferred Qualifications

- Organization has extensive knowledge of and experience with opioid use disorder, medication for opioid use disorder, and the criminal justice system.
- Organization has close connections with a local university with experience in behavioral health program evaluation in the criminal justice setting.
- Organization will be able to access an IRB board that can approve the evaluation plan.
- Organization has experience assessing behavioral health and supervision agency capacity to support alternatives to incarceration.
- Organization has experience collaborating with criminal justice professionals.

8. Submission Requirements

Proposals should be limited in length to 10 pages, single-sided and contain the following:

Organization Information

- 1. Letter of Transmittal on organization letterhead, including:
 - a. A statement that the terms & conditions in the proposal are valid for 180 days from the submittal deadline.
 - b. A statement that, to the best of the organization's knowledge, all information provided is accurate and

complete.

- c. A signature of an individual authorized to bind the prospective organization contractually.
- 2. Organization Contact Information including name, address, contact person, email, and phone number.
- 3. Concise Organization Description including nature, size, locations, and expertise.
- 4. Organization Experience Provide concise project summaries of two recent projects that demonstrate the organization's capacity to complete the scope-of-work associated with this RFP or a concise summary of services that would lend to effective implementation of this project.
- 5. Staff and Subcontractor Experience including a concise description of the Program Coordinator's professional qualifications and experience with projects of a similar nature to that described in this RFP, a general description of subordinate staff's experience in their area of expertise as it pertains to this project, and a description of key subcontractors. Concise resumes may be included in an appendix that does not count towards the proposal's page limit. If the Program Coordinator or subordinate staff have not been identified, state so and the descriptions will not be required.

- 6. Explanation of the organization's ability to perform all items included in the scope-of-work.
- 7. Project timeline.

Costs & Fees

Successful Proposers must submit a line-item budget that provides a complete breakdown of all costs, including how the costs were calculated. Budgets should be shown on an annual basis. The Year 1 Budget should include October 1, 2022 to September 30, 2023. The Year 2 Budget should be from October 1, 2023 to September 30, 2024. An optional third-year Budget that covers the time period from October 1, 2024 to September 30, 2025 should also be included.

9. Organization Selection

The Woonsocket Police Department will select the organization it determines to be most qualified and responsible. Proposal cost shall not be the sole factor used in the selection process. Criteria used to assess proposals will include:

- 1. Completeness and timeliness of proposal (5 points)
- 2. Organization's Experience with similar projects and quality of said projects (10 points)
- 3. Staff/subcontractor qualifications compared to the requirements of the project (10 points)
- 4. Ability to address the items in the scope-of-work in the timeframe requested (10 points)
- 5. Cost and fees (20 points)

10. Conditions

Not all conditions may be relevant to this bid.

- 1. **Regulatory Adherence:** Services provided by the selected organization and its subcontractors shall be performed in accordance with all applicable local, state, and federal laws, regulations and guidance.
- 2. Liability & Insurance: The Woonsocket Police Department agrees to indemnify and hold the owner harmless from any claims arising out of any act or omission (negligence) of the Department or its employees, servants, agents, assigns, contractors and representatives in the performance of the above- described actions and that all contractors shall provide and maintain in full force and effect insurance in which the City shall be named as an "additional insured. Coverage shall be not less than \$1 million per occurrence and \$2 million in aggregate.
- 3. **File Format:** All final deliverables to be submitted in paper and electronic format unless otherwise specified by the Department.
- 4. Response Preparation: The Department shall not assume liability for expenses incurred by a respondent, or

- prospective respondent, in connection with the preparation or delivery of a response, a finalist interview, or any other action related to this RFP's selection process.
- 5. Payment: Payment shall be made on a reimbursement basis for services in the Scope-of-Work.
- 6. By submitting a response to the RFP, each firm waives all rights to protest or seek remedies whatsoever regarding any aspect of this RFP, the selection of a firm or firms with whom to negotiate, the rejection of any or all offers to negotiate, or a decision to terminate negotiations.

Grant Provisions

The following conditions and requirements must be complied with by all parties working on this project. Not all grant conditions may apply to your role in the project.



Applicability of Part 200 Uniform Requirements

The Uniform Administrative Requirements, Cost Principles, and Audit Requirements in 2 C.F.R. Part 200, as adopted and supplemented by DOJ in 2 C.F.R. Part 2800 (together, the "Part 200 Uniform Requirements") apply to this FY 2021 award from OJP.

Effect of failure to address audit issues

Among other things, the OJP may withhold award funds, disallow costs, or suspend or terminate the award. DOJ, including OJP, also may take other legal action as appropriate.
