# **INTRODUCTION**

The Rhode Island Turnpike and Bridge Authority (RITBA) is seeking bids from factory authorized dealers to provide a Racon (Radar Transponder Beacon).

Due date for bids is no later than 2:00pm April 15, 2024, at which time they will be publicly opened. Bids must be in a sealed envelope clearly marked "IFB No. 24-04 Racon (Radar Transponder Beacon). RITBA will not accept electronic bid submissions (email, web, fax, etc.) or late bids under any circumstances. RITBA accepts no financial responsibility for any costs incurred by a firm in responding to this IFB, participating in oral presentations, or meeting with RITBA prior to being awarded the contract. The proposals in response to this IFB become the property of RITBA and may be used by RITBA in any way it deems appropriate. All information submitted in response to this IFB is deemed public and subject to disclosure unless a separate redacted public copy is submitted, regardless of whether the information is marked confidential/proprietary. Firm's may redact in the public copy any trade secrets or commercial or financial information which is of a privileged or confidential nature pursuant to the Access to Public Records Act (R.I. Gen. Laws § 38-2 et. seq.). If Firm does not submit a redacted public copy, RITBA assumes that firm is not seeking confidential treatment for any of its information and thus, all information is subject to public disclosure. By submitting a proposal, the firm certifies that it has fully read and understands the IFB, has full knowledge of the scope of work to be provided, and accepts the terms and conditions under which the services are to be performed. RITBA will be the sole judge in determining as equivalent products (if applicable).

The phrase "executive or administrative head or heads" shall include anyone serving in the positions of director, executive director, deputy director, assistant director, executive counsel, chief of staff or state court administrator.
