# I-195 Redevelopment District Request for Proposals For Park Consulting Services

# Deadline for Submissions: Friday, January 5, 2024 by 3:00 P.M.

The I-195 Redevelopment District ("District") is soliciting proposals from firm(s) qualified to provide park consulting services to support 195 District Park ("District Park") in Providence, Rhode Island. The selected firm will:

- Provide tactical advice to support the growth of District Park.
- Assist with current and future park programming development.
- Advise the District on park policies and operations.

#### **About the District**

The District and its governing Commission were created in late 2011 to oversee the redevelopment of land made available in downtown Providence as a result of the relocation of Interstate 195. The Commission is focused on using the land to support growth of the knowledge-based economy in the state by developing a vibrant innovation district and reknitting the communities that were separated for decades by an elevated highway. The 26-acre District is comprised of individual parcels, the majority of which are developable land. Completed, planned, and under construction projects in the District include office, lab, residential, and hospitality uses.

The District is led by an Executive Director and has a staff of eight. There are two full-time positions and two part-time positions dedicated to District Park.

# **About District Park**

District Park is a seven-acre urban park located along the Providence River. Connected by the Michael Van Leesten Memorial Bridge, District Park connects the east and west sides of the city and has views of the skyline and the Providence River.

District Park opened in 2019. It is heavily programmed with approximately a hundred unique events held between April and November 2023, and two seasonal, semi-permanent food and beverage establishments: a beer garden with a food truck program and an ice cream vendor. Events include concerts, community gatherings, art markets,

conferences, family activities, fitness and movement classes, film screenings, and more. The District runs a grant program to support events that are free and open to the public. There are approximately 5,000 visits to the Park daily and about 1.5 million total visits to date in 2023.

The District is developing an approximately 3,500-SF park pavilion that will include year-round food service operated by the Isle Brewers Guild in partnership with Seven Stars Bakery, public restrooms, and a park office. Construction will begin in 2024.

# **Scope of Work**

The District is seeking a forward-thinking firm with the background, knowledge, and demonstrated record of execution to serve as an on-call park Consultant ("Consultant"). The Consultant will make recommendations and be knowledgeable on topics and best practices including but not limited to: urban park operation and management, park programming and activation, open space maintenance, revenue generation, fundraising, capital improvement plans and policies, and organizational development. Tasks may consist of the development of fee structures, private event policies, and an advanced programming strategy.

# Form of Engagement

The selected firm(s) will be hired on an on-call basis, which will allow the District to rely on the firm as needed. On a project-by-project basis, the District will approve a work order which will include a scope of work, budget, and timeline. Given the numerous projects the District is working on, the expectation is that communication and interactions with District staff, in person or by phone, will occur at least monthly. Additionally, the Consultant may be expected to present to the District or at in-person public meetings.

# **Proposal Requirements and Selection Process**

## Proposals should include the following:

- A general description of the firm and its qualifications for this consultant role.
- A description of the team proposed for this work, including identification of key staff, their resumes, and specific roles, as well as any relevant licensure in Rhode Island.
- Describe other accounts involving similar services, in particular, identify any governmental, public authority, public agenda, quasi-governmental entities, non-

profits, or conservancies for which you serve or have served. Describe the role and experience of key personnel assigned to other similar accounts who will be assigned to this account.

- Please provide three (3) references for organizations for which the firm has provided services (current governmental or quasi-governmental preferred).
   Provide the name of the organization, services and date(s) provided, contact name, telephone number, and email.
- A fee proposal which containing all contract costs, including:
  - 1. The customary hourly rate of each person whose resume is provided in response to the requirements above.
  - 2. Any flat fee proposal or other fee structure.

Although the proposed fees will be taken into account, the District reserves the right to negotiate a lower or different fee structure with any firm selected.

# **Administrative Proposal Elements**

- Acknowledgement of the Conflict-of-Interest Affidavit requirements (see Appendix A).
- Certification that a Certificate of Good Standing from the Rhode Island Division of Taxation will be delivered to the District upon award.
- A listing of all current and on-going contracts which may be of conflict of interest.
- A disclosure of all outstanding financial obligations with the State of Rhode Island.
- Completion of and signature the ISBE participation plan form attached as part of Appendix B.
- Acknowledgement of the following insurance requirements:
  - During the contract term, the Consultant shall keep in full force and effect, at Licensee's expense, the following insurance coverage:
    - (i). Comprehensive General Liability with coverage limits of not less than \$1,000,000 combined single limit per occurrence and \$2,000,000 annual aggregate;

- (ii). Worker's Compensation Insurance as required by the General Laws of Rhode Island;
- (iii). Commercial Auto Liability with limits of \$1,000,000;

The District will not provide any reimbursement for any cost associated with the development or presentation of a proposal.

The District will initially score the proposals applying the aforementioned evaluation criteria to identify up to three finalists. The three finalists will be interviewed by the District. The District reserves the right to adjust the initial scores using the evaluation criteria above based on the interview.

# **ISBE Participation**

The Rhode Island Department of Administration has defined an ISBE as a small business enterprise that is owned by one or more individuals who are women or minorities as defined by R.I. Gen. Laws § 34-17.1-3 that is owned or controlled by one or more individuals with disabilities as defined by R.I. Gen. Laws § 37-2.2.-2. To be recognized, the business must be certified as either:

- A minority business enterprise by the Office of Diversity, Equity, and Opportunity, a division in the Department of Administration ("ODEO");
- 2. A women business enterprise by ODEO; or
- 3. A Disability Business Enterprise by the Governor's District on Disabilities.

The District supports the fullest possible participation of ISBEs in the procurement of services.

# A. Proposer's ISBE Responsibilities (from 220-RICR-80-10-2)

- 1. Proposal of ISBE Participation Rate. - 2. Failure to Submit ISBE Participation Rate. Any Proposer that fails to submit a proposed ISBE Participation Rate or any requested substantiating documentation in a timely manner shall receive zero (0) ISBE participation points.
- 3. Execution of Proposed ISBE Participation Rate. Proposers shall be evaluated and scored based on the amounts and rates submitted in their proposals. If awarded the contract, Proposers shall be required to achieve their proposed ISBE Participation Rates. During the life of the contract, the Proposer shall be responsible for submitting all substantiating documentation as reasonably requested by the District's MBE/WBE/DisBE Coordinator including but not limited to copies of purchase orders, subcontracts, and cancelled checks.
- 4. Change Orders. If during the life of the contract, a change order is issued by the Division, the Proposer shall notify the District's MBE/WBE/DisBE Coordinator of the change as soon as reasonably possible. Proposers are required to achieve their proposed ISBE Participation Rates on any change order amounts.
- 5. Notice of Change to Proposed ISBE Participation Rate. If during the life of the contract, the Proposer becomes aware that it will be unable to achieve its proposed ISBE Participation Rate, it must notify the District, and the District and the Proposer may agree to a modified ISBE Participation Rate provided that the change in circumstances was beyond the control of the Proposer or the direct result of an unanticipated reduction in the overall total project cost.
