 - A2 No separate cost for work under the movable barrier is included the barrier will be moved by RITBA if required for access to repairs.
 - Q3 Please clarify Note 9 on Sheet 5 of 8 of the project plans regarding power washing.
 - A3 Power washing relates to surface preparation for patches exposed to traffic for longer than 3 days before the application of sealer. See revised specification Section 818 included with this addendum.
 - Q4 Will a stageing/storage area be provided by RITBA at the Mt Hope Bridge and Newport Bridge?
 - A4 See the Pre-Bid Meeting PowerPoint Presentation included with this Addendum.

Q5 – Please confirm that the deck repair operations will be allowed to proceed, as has been typical in the past, in an orderly/efficient fashion progressing from one end of the bridge to the other rather than a "hop scotching", location to location manner.

CONSTRUCTION DETAILS

The applicable requirements of the Standard Specifications shall apply except as modified and supplemented by the following and the Contract Drawings.

SECTION 818 - PORTLAND CEMENT CONCRETE BRIDGE DECK REPAIR

818.01 DESCRIPTION

Delete the first paragraph and replace with the following:

This work shall consist of: locating, under the direction of the Engineer, spalled or delaminated areas for the length and width of the Mount Hope bridge deck from curb to curb and abutment to abutment and performing concrete deck repairs.

Additionally, work shall include the following Optional Work to be performed at the direction of the Engineer: Locating spalled or delaminated areas on the Newport Pell Bridge deck within areas and to the extent directed by the Engineer and performing concrete repairs.

Work (both under base contract pay items and optional work pay items) shall include delineating the extents of individual spalls or delaminations under the direction of the Engineer; saw-cutting the perimeter as defined to depth shown on Contract Drawings; removing deteriorated concrete within sawcut limits; coating existing steel exposed by concrete removal with Zinc-Rich Rebar Primer; providing formwork as required for full depth patch repairs; and furnishing and placing rapid-setting concrete with aggregate, all as indicated in the Plans and in accordance with these Specifications. Removal of all debris to the satisfaction of the Engineer and proper disposal is considered incidental and shall be included within the Contract Unit Price per Square Foot Bid.

Newport Pell Bridge Specific Information:

The Contractor's attention is drawn to the fact that the Newport Pell Bridge has a movable median barrier. The median barrier will require localized movements to perform patch repairs located at the centerline of the bridge. Segments of the barrier can be moved locally to access the centerline deck area for repairs. Work associated with the movement/replacement of localized sections of the median barrier is incidental and will not be measured for separate payment.

All work for this item shall be coordinated with the RITBA maintenance department, other on-going bridge work that may require lane outages, and any other incidental work in accordance with the requirements of Subsection 104.08 of these Specifications.

Delete paragraphs (a) and (b) without replacement.

818.02 MATERIALS

818.02.1 Concrete

Delete the first paragraph in its entirety and replace with the following:

Cement for deck repairs on both the Newport Pell and Mount Hope Bridges shall be Quikrete® Rapid Road Repair with Fibers® meeting all minimum requirements corresponding to Class HP(AE) material as set forth in Subsections 601.01.1 and 601.03.1, Classification and Proportioning, respectively, with the following modifications, using the maximum aggregate extension specified by the manufacturer and accepted by the Engineer

Delete the last paragraph beginning with, "Field conditions..." in its entirety without replacement.

818.02.2 Epoxy Adhesive

Add the following:

Epoxy Adhesive shall be used as indicated in Contract Drawings.

818.02.3 Corrosion Inhibitors (Add this new section)

For both bridges, Conproco ECB or ThoRoc Zinc-Rich Rebar Primer or approved equal shall be applied to all cleaned steel surfaces in accordance with the manufacturer's recommendations and accepted by the Engineer.

818.03 CONSTRUCTION METHODS

818.03.1 Removal of Deteriorated Concrete

In the third paragraph, replace "of 3/4-inch" with "as indicated on the Contract Drawings".

In the fifth paragraph, replace "30-pound" with "20-pound" and "15-pound" with "10-pound".

For Mount Hope only, delete the sixth paragraph in its entirety and replace with the following:

In areas where grid bars are found to be entirely surrounded by deteriorated concrete or where the entire cross bar is exposed by the removal of deteriorated concrete, additional concrete removal shall be performed to provide a minimum of ¾-inch below the top surface of the cross bar and main bearing bar as applicable.

818.03.2 Preparation of Sound Concrete and Reinforcing

In the second paragraph, replace all references to "epoxy adhesive" with "epoxy adhesive or ThoRoc Zinc-Rich Rebar Primer as indicated on the Contract Drawings".

At the end of this section, add the following paragraph:

Following the manufacturer's recommended cure period, all surfaces shall be moistened with clean water and all excess standing water removed by vacuuming or clean rags for a saturated surface dry condition.

818.03.3 Forms for Full Depth Removal

Add the following at the end of this subsection:

Newport Pell Bridge: Under the Formwork Installation Optional Work Contract Allowance, full depth joint repairs shall be performed as directed by the RITBA utilizing time and materials costs for the additional work of installing the required formwork (including labor, equipment, and material specific to that work), with all other costs covered by the daily and unit price costs provided for the partial depth repairs. Forms installed for full-depth patch repairs are the responsibility of the Contractor and the Contractor shall ensure that the forms, while left in place, are sound and intact and that there is no danger of the form or any part thereof falling. The forms shall be removed by the Contractor before the end milestone date of the contract or within one year of installation or when required due to form condition – whichever comes first.

818.03.4 Epoxy Adhesive

Add the following:

Epoxy Adhesive shall be used as indicated in Contract Drawings.

818.03.5 Placing and Finishing Concrete

Add the following to the end of the first paragraph:

The elevation of the patches, when fully cured shall match the elevation of the adjacent existing concrete as closely as possible to minimize effects to ride quality.

Add the following at the end of the second paragraph:

The surface of the new concrete shall be provided with a surface texture to match the existing surface as closely as possible. At each differing surface texture, the Contractor shall provide a plan for providing this finish to the Engineer before the start of work and perform a minimum of five square feet sample for approval by the Engineer before the start of work. Immediately following float finishing, the surface shall be transversely broomed to an amplitude of at least 1/16-inch.

Curing shall be performed as required by the manufacturer of the repair material. Traffic may be permitted on full and partial depth patch repairs after curing periods as defined by the manufacturer and as approved by the Engineer.

Delete the fourth and fifth paragraphs in their entirety without replacement.

Add the following paragraph:

Once patching is started, it shall be continued on a daily basis, weather and lane outages permitting, and completed in one continuous operation.

818.03.6 Application of Penetrating Sealer to Patches (Add this new section)

Newport/Pell Bridge: After the patched area has cured completely, and not later than 3 days after the patch is placed, apply penetrating sealer on patch area to at least 3 inches beyond the perimeter of the patch on all sides. The area to be sealed should be clean and sound with the surface preparation as required by the manufacturer's specifications. The cost for cleaning and application of the sealer to patches is to be included in the square foot unit price for deck patch repairs.

Mount Hope Bridge: After the patched area has cured completely, apply penetrating sealer on patch area to at least 3 inches beyond the perimeter of the patch on all sides. The area to be sealed should be clean and sound with surface preparation as required by the manufacturer's specifications. Patches may remain unsealed for up to one month; patches older than 3 days shall be pressure washed as part of the surface preparation. The cost for cleaning and application of the sealer to patches is to be included in the square foot unit price for deck patch repairs.

818.04 METHOD OF MEASUREMENT

Delete and replace with the following:

For both bridges:

Work under this Specification will be measured by the number of square feet of patch repairs actually made in accordance with the Plans under the Pay Items and Optional Work Pay Items included in this Specification and/or as directed by the Engineer. For Joint Header Patching measurement, at locations where repairs are made to both the vertical and horizontal face, measurement shall be made for the full square footage along the horizontal face plus the square footage along the vertical face excluding the top three inches of the face along the length of the repair. This is to preclude the corner portion of the joint header from being measured twice for payment.

Work for the installation of under deck formwork at full depth joint header repairs at locations on the Newport Pell Bridge directed by the RITBA shall be measured for payment based on submitted and approved Time and Materials documentation in accordance with the Contract Specifications and Special Provisions to include all labor, materials, and equipment required for the installation and removal of full depth joint header repair formwork below the deck.

For the Mount Hope Bridge the costs of Maintenance and Protection is not measured separately but included in the unit price for patch repairs.

818.05 BASIS OF PAYMENT

Delete the first paragraph and replace with the following:

Optional Work on the Newport Pell Bridge:

The accepted quantities for work under this Specification, with the exception of the installation and removal of full depth joint header repair under deck formwork will be paid for at the Contract unit price per square foot as listed in the Proposal under the Pay Items included under this Specification. The prices so-stated constitute full and complete compensation for all labor including sounding to delineate repairs, support for review of repairs and final approval of repair locations by RITBA, tools, materials, equipment, demolition, surface preparation, repair materials, furnishing and application of Zinc-Rich Rebar Primer, Epoxy Adhesive, and all other incidentals required to complete the work, complete and accepted by the Engineer.

Work for the installation of under deck formwork at full depth joint header repairs at locations directed by the RITBA shall be paid for by Time and Materials in accordance with the Contract Specifications and Special Provisions to include all labor, materials, and equipment required for the installation and removal of full depth joint header repair formwork below the deck.

For the Mount Hope Bridge:

Revise the last sentence in the first paragraph to read as follows:

The prices so-stated constitute full and complete compensation for all labor including sounding to delineate repairs, Traffic Control, tools, materials, equipment, surface preparation, ThoRoc Zincrich Rebar Primer® and all

other incidentals required to complete the work, complete and accepted by the Resident.

The material specified is rapid setting for Type 2 Repairs


