- Q1. Due to the scope of the project, could you please confirm whether Builder's Risk Insurance will be required?
- A1. Yes, the following coverage will be requested at the time of tentative award:

Certificates of Insurance in the amounts set forth in the <u>State's General Conditions of Purchase</u> naming the URI Board of Trustees, the University of Rhode Island and State of Rhode Island as additional insured. **IMPORTANT NOTE: Certificates of Insurance must reference the University of Rhode Island Bid Solicitation Number.**

Insurance General Requirements:

General Liability in the amount of \$1 Million.

Property - \$500,000 each occurrence, \$500,000 annual aggregate.

Auto liability coverage in the amount of \$1 Million each occurrence combined single limit.

Worker's Compensation -\$100,000 coverage B.

Builder's Risk Insurance – Coverage equal to face amount of contract for construction.
