1. CLASSIFICATIONS AND SCOPE:

1.1 This Specification covers the construction and materials for Polyester Bed Pillows composed of flame resistant materials as described herein.

1.2.1 Grade, Size, and Weight

1.2.1.1 Filling – Shall be 100% White Virgin Polyester, 5 Denier (non-coarser).

1.2.1.2 Ticking

- **Style A -** Cloth Ticking, Twill, Cotton 7.oz sq. yd. (6.5 oz. min.) shall be flame resistant and conform to Type II, Class 2, of Federal Specification CCC-C-436 of latest issue.
- **Style B -** Vinyl/Nylon Laminate. Flame resistant, Anti-Static and Anti-Bacterial (10 oz. sq. yd. Min.) Ticking shall be certified to be in full compliance with Veterans Administration Specification X-1636 of the latest issue.
- **1.2.1.3 Sizes** Pillow shall be 21" x 27" cut size with a tolerance of + or of $\frac{1}{2}$ inch. Pillow shall be 20" x 26" finished size
- **1.2.1.4 Weight:** Finished weight shall be approximately 1 lb. 8 oz.

2. APPLICABLE DOCUMENTS:

- **2.1** The following specifications, of the issue in effect on date of Invitation to Bid, for a part of this Specification. Federal Spec. CCC-C-436 RI Bedding and Upholstered Furniture Laws 23-26-29 G.L. 1956.
- **3. REQUIREMENTS:** A certified statement furnished by the manufacturer on their standard letterhead and signed by an officer or other responsible official, stating that the pillow offered and proposed to be supplied meets or exceeds all of the requirements of this specification must be submitted with each bid.
- **3.2 WORKMANSHIP:** Shall be first class in every respect, pillows shall be delivered clean and ready to use.

4. SAMPLING, INSPECTION AND TEST PROCEDURES:

- **4.1 Sampling** The successful bidder shall allow the State the right to open for inspection 1% of the pillows delivered to determine compliance with specification. The State of Rhode Island reserves the right to reject upon inspection. Rejection of the random sample(s) shall be grounds for rejection of the entire shipment. - **4.2 Inspection:** The pillows shall have a label attached to conform to legal requirements of the State of Rhode Island law by the Inspection Division of the RI Department of Business Regulation, which is Responsible for the enforcement of the statues regulating the manufacture and sale of articles of Bedding or upholstered furniture. Inspection may be done at the destination or at the place of manufacture.

4.3 Testing – Flammability Performance

- **4.3.1** Cloth Ticking (Style A) shall meet specification under paragraph 3.5 of Federal Specification CCC-C436E of February 14, 1986.
- **4.3.2 Vinyl/Nylon Laminate** (**Style B**) shall meet specifications under NFPA 701, 1989 edition, Chapter 10 describing field test procedure.

5. PREPARATION FOR DELIVERY:

- **5.1 Dating:** All pillows delivered under this specification shall bear the date of manufacture.
- **5.2 Packaging:** Pillows shall be individually packaged in a manner commonly used in vendors

transportation or commercial transportation, so constructed as to insure acceptance and

safe delivery to the location called for in the contract or purchase order.

5.3 Marking: Unless otherwise specified, shipping containers shall be marked with the description of

contents, the name and address of manufacturer, order number, name, and address of

ordering agency.

- **6. FIBER CONTENT:** Items shall be labeled as to the fiber content in accordance with Federal Trade Commission, "Textile Fiber Products Identification Act."
- **7. BID SAMPLES:** Buyer, subsequent to bid opening, may instruct (3) lowest bidders to submit samples. Samples shall not be submitted with bid.
